District and County Councillors Report

Cllr Susan Barker reported:

- Uttlesford Local Plan due to the Inspectors concerns over Garden Communities the plan has been withdrawn for further thought and will be resubmitted at a later date.
- Stansted Airport -Decisions regarding the future proposed expansion of the airport expected soon from Uttlesford District Council (UDC).
- Essex County Council (ECC) Budgets will soon be set for 2020/2021, it is expected that there will be provision for extra funding for Highways and towards Climate Change policies. Changes expected concerning rural bus services and there is a need to encourage more use of the service.
- Scheme to plant more trees in the district.
- Grants to be made available for creative thinking, full details will be issued in due course.
- The Council raised concerns regarding the unsafe and deteriorating condition of the pathway along Church Lane from the Church to the A1060. Cllr S Barker asked the Clerk to send details to Highways and copy her in to the emails.
