Speeding and road safety has long been a matter of great concern to White Roding parishioners and the Parish Council over many years have contacted Essex Highways and ECC Councillors over these issues and the Parish Council will continue to do so in the future until a solution is found.

A request to the Local Highways Panel (LHP), voicing once more the Parish Council concerns and dangers over the consistent speeding through the village and the safety of parishioners and children, to be emailed (as required by the LHP) to ECC Cllr Susan Barker for her approval and submission to the LHP.

Speeding Indicator Devices (SID's) It has been confirmed that Essex Highways are presently reviewing and updating their rules and requirements regarding installations of SID's but no date of issue or implementation has yet been published.
Once the Parish Council have full details they will proceed to see if it is feasible to have SID's erected at both ends of the village.
