White Roding need more smaller homes rather than the large ones in the plan.

Many residents are living in properties which are much too large for them but do not want to leave the village. There is very little opportunity to downsize in White Roding.

Residents of the new properties will have to walk on the busy 1060 to access the local amenities and bus stop.

A pavement should be provided to link this part of the village with the centre off the village.

UTT/232/2384/HHF Grange Barn Church Lane, White Roding – Replacement of shed, greenhouse and pool house building. White Roding Parish Council raised no objections to this planning application.

UTT/23/2633/FUL Walkers Farm Poplars Lane - replacement agricultural building. White Roding Parish Council raised no objections to this planning application.
