64/14 PUBLIC FORUM

The members of the public spoke about concerns regarding the continuing flooding along Marks Hall Lane which has been a major issue that is an on-going and deteriorating problem since first being reported to Highways in December 2013. One of the home owners in the area had attempted to rod out the underground culverts but it really needed the type of equipment available to the Highways department to ensure a more permanent solution to the problem. Highways representatives have now viewed the area and agreed that the culverts and piping needed urgent attention which they would action as soon as possible. Although the ditches along the lane urgently need clearing the responsibility for these remain with the landowner and not Highways

• District and County Councillors Report – Cllr S Barker reported on the Local Plan with reference of the need to build 580 more houses each year in the Uttlesford area. Epping Forest, Harlow and Uttlesford have a group duty to co-operate in this matter. It is proposed that further consultation regarding where these houses should be built will to take place in the coming year.

• Uttlesford District Council to reduce their precept by 3% for the coming year and there is a possibility they may also agree to fund the costs of PCSO.

UDC now have new Planning procedures in place re planning applications and advice given.

There is now no need to provide Affordable Housing on any building development of 10 or fewer houses.

Councillors requested that Cllr Barker to check and inform the Parish Clerk on the current procedure for informing Parish Councils of planning applications for their area that have been withdrawn after the original submission to UDC Planning department.
