Over the winter period the flooding problem within the village had proved to be an ongoing problem, and it is known that it had caused 6 cars had been written off. Highways personnel, due to a lack of communication and knowledge of the area???, originally went to Marks Hall Lane Margaret Roding, but some culverts in Marks Hall Lane White Roding were eventually pumped out and Highways are now due to come back (to White Roding we hope) during the financial year

2015/16 to ensure some remedial work is carried to prevent a possible recurrence of the problems during the coming year.

This will be monitored by Councillors.

The grass verges in Marks Hall Lane are constantly being eroded, Highways to be contacted to see if there are any measures that can be put in place to prevent this problem getting worse.
