- UDC had announced there would be a delay in the date of agreeing the Local Plan being as ECC had, without any consultation with the District Councils involved, announced the possibility of three new garden towns with two being in Braintree and Colchester area but no indication of as to where the third may be.
- No information on possible new access to the M11. Considerable objections to the possible increase in traffic in the areas local to the M11 had been raised.
- Stanstead Airport are expected to put forward plans to allow for expansion of traffic from 35 million passengers a year to 45 million passengers a year
- Parishioner with complaints regarding the changes to air routes that have caused an increase air traffic over villages in the area should contact Stanstead Airport.
