District Councillor Cllr M Lemon Reported:

Local Plan hopefully to completed by March 2018. Scope within the original plan to meet required increases. Although extra housing is required throughout the Uttlesford District, the north areas of the district seems to be of increased interest regarding providing extra housing, but it is also of great importance that whatever future housing needs are finally approved proposals regarding changes to the infrastructure required to cope with all the future increases must be put in place.

Stansted Airport – will the published increase of passengers from 35.5 million to 44.5 million require a second runway. This would make Stansted eventually becoming larger than Gatwick possible.
